STREET EXCAVATION FEE SCHEDULE

1. Base fee. Any application for Street Excavation of a Township Street shall be accompanied by a filing fee of \$200.00. Such application fees will cover administrative and engineering costs incurred by the Township during processing and review of the application.

2. Oversized Street Cuts and Excavations. For any street cut larger than 40 square feet, there shall be an additional charge of \$50.00 per each additional 20 square feet of excavation or fraction thereof.

3. Streets Resurfaced within past Three Years. Any street resurfaced within the past three years will be approved for excavation only in the event of an emergency. The street cutting fee in such event shall be calculated as set forth above with a minimum fee of \$1,500.00.

4. Exemption. Any department of the Township shall be exempt from all fees, provided that such exemption shall not apply to any municipal authority, including any municipal authority created by the Township.

NOTICE

Street restoration to conform to directives as outlined in Muhlenberg Township code, Chapter 125, Article 3.

Under penalty of intentional misrepresentation and/or perjury, I declare that I have examined and/or made this application and is true and correct to the best of my knowledge and belief. Where no work has been started within 180 days after the issuance of a permit or when more than 180 days lapse between approvals of required inspections, such permit shall be void.
